### **COMPLEMENTARY MINERAL FEED FOR DOGS AND CATS**

### **DESCRIPTION**

**ENTERO APPETITE**, thanks to the action of protected SODIUM BUTYRATE restores the balance of the INTESTINAL MICROBIOLOGY and IMPROVING THE ABSORPTION of nutrients through the structural restoration of the intestinal walls. ENTERO APPETITE promotes the secretion of immunoglobulins, which are responsible for an effective immune response in the intestinal mucosa. It is a particularly attractive nutritional support to be used in cases of metabolic disorders and diarrhea, of pharmacological treatments, in situations of food moving too quickly through the digestive system, malabsorption caused by food intolerances, and in cases of metabolic stress due to poor diet management, such as sudden changes in food, seasonal changes or travel stress.

### **TECHNOLOGY**

Envelopes and preserves the integrity of the active ingredients against degradation over time caused by atmospheric agents (light, humidity, oxygen, etc.) and against oxidation from the oxidizing substances (iron, copper, choline) present in the feed. Allows the association of incompatible molecules with each other. Slowly releases its contents, rendering them bioavailable and active in the area of the intestines most capable of absorbing them.

### **COMPOSITION**

Calcium carbonate, carob meal, vegetable hydrogenated oils and fats (from palm), yeasts products from *Saccharomyces cerevisiae*, mojave yucca, sodium salts of organic acids (sodium butyrate\*), calcium sulphate dihydrate, vegetable oils and fats (soya), maize starch, alvcerine.

### **DIRECTIONS OF USE**

Mix with traditional food, both wet and dry. After mixing it is important not to cook the product.

# **RECOMMENDED QUANTITIES**

0.5-1 g/kg of body weight per day, depending on the needs of the animal. Do not exceed the recommended quantity of 22 g per day. (1 teaspoon: approx. 4 g, 1 tablespoon: approx. 11 g).

# **METHOD OF CONSERVATION**

Produced 3 years before the minimum conservation date indicated. The term refers to goods in sealed original packaging and stored in a cool and dry place.
